1. STUDENT COUNCIL PRESIDENT'S REPORT

For example, the school is currently planning a clothing drive to assist those in need, as well as the "souper bowl" (that's S-O-U-P-E-R). This is just one of the many ways that Gregory gives back.

9. APPROVAL OF SALE OF WEST END SCHOOL

That the Board approve the following Resoluton:

RESOLUTION

- A. The Board of Education of the City of Long Branch, in the County of Monmouth ("Board") is the owner of property located in the City of Long Branch located at 132 West End Avenue known as the West End School;
- B. The Board has heretofore filed with the Department of Education a Long-Range Facilities Plan in which the Board, in cooperation with the Department of Education, agreed to the removal of the West End School from the inventory of schools maintained by the Board;

9. APPROVAL OF SALE OF WEST END SCHOOL (continued)

- C. On November 22, 2013, the Board advertised in its official papers a Notice to Potential Bidders to Purchase The West End School Located At 132 West End Avenue, Long Branch, NJ 07740;
- D. In response to the advertisement, an offer was received from the Menachem Learning Institute, a New Jersey Non-Profit corporation located at 620 Ocean Avenue, Long Branch, New Jersey ("Menachem"). The offer consisted of a signed Purchase and Sale Agreement ("PSA") between Menachem and the Board, together with the initial deposit of \$50,000.00 as evidenced by an official check dated January 22, 2014 issued by TD Bank, an Affidavit of Non-Collusion and a Bidder's Disclosure Statement;
- E. The PSA signed by Menachem is in the form required by the Offer Specifications;
- F. The purchase price offered by Menachem is \$3,305,800.00. According to the PSA, an additional \$150,000.00 must be delivered to the Board by Menachem within seven (7) business days in the event the Board accepts the offer of Menachem, for a total deposit of \$200,000.00 to be held in escrow by the attorney for the Board McOmber & McOmber, P.C. in its Attorney Trust Account.
- G. The PSA provides for a covenant running with the land which requires the Board to consent to the use of the West End School for a public school, private school or charter school. The Board has already given consent to Menachem to use the West End School for "after-school religious education, as well as pre-school religious education." The Board has also consented to permitting Menachem to "evolve into a full-time religious school, kindergarten through 8th grade." The consent of the Board is limited to Menachem and will not apply to any purchaser, assignee, tenant or lessee from Menachem and only the aforementioned uses will be permitted. Finally, the consent issued by the Board is based on the representation of Menachem that the students attending the Menachem religious school will not come from the public school student population in Long Branch;
- H. The closing date is set for July 18, 2014. However, in the event the George L. Catrambone School located on Park Avenue in Elberon is not completed by June 30, 2014, the Board has the option of continuing to use the West End School through November 18, 2014 at a cost of \$5,000.00 per month provided Menachem has already purchased the West End School. Further, in the event Menachem is applying for Application for development from the Long Branch Planning Board or Zoning Board, Menachem may request that the Board extend the closing date through November 18, 2014.

9. APPROVAL OF SALE OF WEST END SCHOOL (continued)

- In all events, Menachem will have the obligation to purchase the West End School provided it obtains a mortgage commitment in the amount of eighty percent (80%) of the purchase price by March 30, 2014. In the event Menachem has not obtained a mortgage commitment from a lender for a mortgage in the aforesaid amount, Menachem may either waive the mortgage contingency and proceed to closing or cancel the PSA and receive the return of its deposit; and
- J. The Superintendent of Schools and the School Business Administrator have recommended to the Board that the Board sell the West End School to Menachem in accordance with the terms of the PSA.

NOW THEREFORE, be it resolved by the Board as follows:

- 1. The Recitals set forth above are incorporated herein by reference.
- 2. The Board does approve the offer of Menachem as more fully set forth in the PSA.
- 3. The Board hereby authorizes and directs its President and Secretary to sign the PSA with Menachem and to comply with the terms and conditions thereof and to take any and all further action necessary to sell the West End School in accordance with the terms and conditions of the PSA.

3000 TEACHING STAFF MEMBERS

Policy & Regulation 3142

Nonrenewal of Non-tenured Teaching Staff Member

Achieve NJ administrative code recodified NJAC 6A:32-4.6 for procedures for appearance of nontenured teaching staff members before a district board of education upon receipt of notice of non-reemployment to NJAC 6a;10-8.1 requiring minor revisions to the policy and regulation guides. The regulation guide has been revised to provide the Superintendent and the Board with two options on how the Superintendent informs the Board regarding the nonrenewal of nontenured teaching staff members. One option is the Superintendent informs the Board with a written notice and reasons for each recommendation not to renew before May 15 and the second provides for the Superintendent to conduct an executive session with the Board prior to May 15 to review the Superintendent's recommendations and reasons for each recommendation. These two options in the regulation provide greater flexibility to the Superintendent and Board.

Policy & Regulation 3144 Certification of Tenure Charges

A new AchieveNJ subchapter, NJAC6A:3-6 – charges under tenure employees' hearing act, requires revision to this policy and regulation. There have been significant changes to administrative code concerning filing tenure charges for inefficiency. NJSA18:6-17.a requires the Superintendent to file tenure charges of inefficiency when a teacher, Principal, Vice Principal, or Assistant Principal receives substandard evaluation ratings in two consecutive years (policy 3144.12). Another significant change involves tenure hearings being conducted in an expedited manner by Arbitrators rather than Administrative Lay Judges in the Office of Administrative Law. These statute and code changes have been incorporated in this policy and regulation guides.

Policy & Regulation 3221

Evaluation of Teachers

The details of the new requirements of TEACHNJ and AchieveNJ for a teacher whose annual evaluation is subject to student growth percentiles and/or student growth objectives are outline in this policy and regulation. The only discretionary issue in this regulation concerns a code provision that requires a teacher on a corrective action plan (Section H.10.a.) to receive an additional observation. The AchieveNJ code indicates the Superintendent may determine the length of this additional observation. It is recommended the additional observation for all teachers with a CAP be the same length of time as determined by the Superintendent. Therefore, in the event the district files tenure charges against a tenured teacher for inefficiency the district can assert all teachers use a CAP received the same length of time for the required additional observation. The policy and regulation guides include all the details and minimum evaluation requirements of TEACHNJ and AchieveNJ for teachers.

Policy & Regulation 3222

Evaluation of Teaching Staff Excluding Teachers and Administrators

Policy and regulation guides provide the evaluation procedures for teaching staff members excluding teachers, Principals, Vice Principals, Assistant Principals, and other administrators. These teaching staff members identified in this policy and regulation includes educational services staff members, guidance counselors, CST, specialists, school nurses, library/media specialists, occupational therapist, and other teaching staff members working under an educational services certificate. The regulation guide provides the details of the evaluation process. TEACHNJ did not require all the evaluation requirements for this group of teaching staff member, therefore, AchieveNJ administrative code does not have the detailed evolution requirements, however, this policy and regulation aligns the same evaluation process, tenure timelines, and use of SGOs.

Policy & Regulation 3223

Evaluation of Administrators Excluding Principals, Vice Principals and Assistant Principals

Provides evaluation procedures for administrators, excluding Principals, Vice Principals, and Assistant Principals. These administrator positions include supervisors, directors, or any other administrative position in the district working under an administrative certificate. The regulation guide provides the details of the evaluation process. All the evaluation requirements in TEACHNJ for teachers, Principals, Vice Principals, and Assistant Principals and recommended to use for this group

Policy & Regulation 3224

Evaluation of Principals, Vice Principals and Assistant Principals

The revisions to this policy and regulation designate the Superintendent or designee as the authorized and appropriately certified member as the evaluation of a Principal, Vice Principal, or Assistant Principal. Regulation is very detailed as to the evaluation requirements.

Policy & Regulation 4146

Nonrenewal of Non-tenured Support Staff Member

AchieveNJ administrative code recodified NJAC6A:32-4.6, procedure for appearance of nontenured teaching staff members before a district board of education upon receipt of a notice on non-reemployment to NJAC6A; 10-8.1. Several minor revisions were made to policy and regulation guides. Nonrenewal procedures outlined in NJSA18:27-4.1 are the same for nontenured teaching (certified) staff and nontenured (non-certified) staff, however, a Commissioner's decision in 2009 held, among other issues, the May 15 date to notify nontenured staff member of their contract renewal for the next school year only applies to nontenured teaching staff members and not support staff. The Commissioner held the contract renewal notification date for a non-teaching (non-certificated) staff member was the timeline in the language of the governing collective bargaining agreement. This policy and regulation guides have been revised indicating the contract renewal date for nontenured support staff members shall be in accordance with the terms of any applicable collective bargaining agreement, individual contract, or any other agreement between the parties"

The regulation provides the Superintendent and Board two options on how the Superintendent informs the Board regarding nontenured support staff members that are not recommended for renewal. One option is the Superintendent information the Board with a written notice and reasons for each recommendation not to renew before May 15 and secondly, the Superintendent to conduct an executive session with board prior to May 15 to review the Superintendent's recommendations and reasons for each recommendation. The two options provide greater flexibility to the Superintendent and the Board.

Employment Contract

This policy has been revised to remove the provision that indicates a nontenured support staff member's contract will include a probationary employment provision. The revised guide indicates that employment contract may include probationary employment period as most school district do not have a formal probationary employment period (i.e. thirty, sixty, or ninety days) for newly hired staff member. This policy guide contains provisions regarding contract termination, maximum length of contract and other information that should be included in nontenured support staff.
