1. **COMMITTEE MEETING REPORTS**

A) OPERATION AND MANAGEMENT – ARMAND ZAMBRANO - Chair

Mr. Zambrano stated that the Committee met on May 9, 2012 and the following was discussed:

- George L. Catrambone School the Notice of Award and Notice to Proceed had been sent. The ground breaking will take place sometime in July
- Morris Avenue School the internal project will begin at the end of the school and completion is expected to be done by the end of August
- The Buildings and Grounds Department if focusing on upcoming district events with additional concentration on beds, shrubs and trees
- Trees in front of the old High School by the stadium fenced are being replaced and replanted with a berm for drainage
- Ceiling tiles are being replaced and grids are being painted at the Morris Avenue School and the Audrey W. Clark School
- Reflective room numbers are being installed to outside windows at the Middle School with the remainder of the district to follow
- Gym floors are being refinished at Amerigo A. Anastasia School, Gregory School, High School (main and auxiliary) and Middle School (auxiliary)
- The Technology Department has more than doubled the amount of back up storage for schools

B) INSTRUCTION AND PROGRAMS – LUCI PEREZ - Chair

Mrs. Perez reported that the Committee met on May 9, 2012 and discussed the following:

- A new language arts curriculum will be implemented by district teachers for the 2013 school year
- The program "Treasures" will replace SFA in grades K 6
- Students will remain in their classrooms and be grouped by reading levels
- In-services for teachers will be available all summer as well as during the school year. Principals will be required to attend the training sessions as well
- Implementation of Instructional learning pods in Grades 7 8 was also discussed.
 Each pod will be made up of 100 students with teachers from language arts, math, science, social studies and electives providing instruction in these individual subject areas rather than 1 teachers teaching all subjects
- The administration is also reviewing a revision of report cards to make them more standards based, aligning them with common core standards

- 3. For cumulative unexcused absences of ten or more, the pupil between the ages of six and sixteen is truant, pursuant to N.J.S.A. 18A:38-27, and the Building Principal or designee shall:
 - a. Make a mandatory referral to the court program required by the New Jersey Administrative Office of the Courts;
 - b. Make a reasonable attempt to notify the pupil's parent or legal guardian of the mandatory referral;
 - c. Continue to consult with the parent or legal guardian and the involved agencies to support the pupil's return to school and regular attendance;
 - d. Cooperate with law enforcement and other authorities and agencies, as appropriate; and
 - e. Proceed in accordance with N.J.S.A. 18A:38-28 through 31, Article 3B, Compelling Attendance at School, and other applicable State and Federal statutes, as required.
- 4. G. Discipline

- 1. Pupils may be denied participation in co-curricular activities if their attendance fails to meet the standards set forth in Policy No. 2430.
- Pupils may be denied participation in athletic competition if their attendance fails to meet the standards set forth in Board Policy No. 2431.
- 3. No pupil who is absent from school for observance of a religious holiday may be deprived of any award or of eligibility for or opportunity to compete for any award because of the absence.
- 4. In addition to the requirements as outlined in F.3.a. through e. above, a pupil deemed truant shall be subject to appropriate pupil discipline.
- 5. The absence of a pupil missing from school for unexplained reasons will be handled in accordance with Regulation No. 8462.

H. Recording Attendance

- 1. Teachers must accurately record the pupils present, tardy, and absent each day in each session or each class. Attendance records must also record pupils' attendance at out-of-school curricular events such as field trips.
- 2. Teachers must classify and record each absence as excused, unexcused, or truancy.
