The Athletic/Academic Assistant Principal will prepare and promulgate rules of conduct for volunteer athletic coaches. Each volunteer athletic coach will be given a copy of this policy and the rules of conduct.

The following guidelines shall govern the service of a volunteer athletic coach:

- supervision of a head and/or assistant coach employed by the Board; Volunteer athletic coaches may serve only under the direction and immediate

- ω instruction provided to pupils participating in the athletic program; assistant coaches employed by the Board are responsible for the supervision and Volunteer athletic coaches serve only in a support capacity and only head or

- .7 responsibilities; Principal regarding any matters Volunteer athletic coaches must consult with the Athletic/Academic Assistant or questions regarding their duties
- 8. Volunteers shall receive no financial remuneration; and
- 9 responsibilities, with or without cause, by the Superintendent with such action to be recommended to the Board by the Superintendent at the next Board Meeting following relief of duties. Volunteer athletic coaches, may be immediately relieved of their volunteer

All school volunteers must have an approved New Jersey substitute teacher certificate.

The Superintendent shall report annually to the Board on the number of volunteer coaches serving in the district, the duties performed by volunteer coaches, and the number of volunteer hours served, by school athletic program.
